# ABOLISHMENT OF CODE 04 WORKS MAINTENANCE WITH ITS SUB CODES AND GRADES AND AMENDMENT OF CODE DESCRIPTION FOR CODE 02 ELECTRICAL ENGINEERING WORKS AND CODE 08 MECHANICAL ENGINEERING WORKS

The above matter refers.

- 1. All addressees are hereby notified/informed that the Board at its sitting of the 20<sup>th</sup> of January 2022 resolved as follows:
  - 1.1. To Abolish Code 04 Works Maintenance with all its Sub Codes and Grades.
  - 1.2. To Amend the description of Code 02 Electrical Engineering Works and Code 08 Mechanical Engineering Works to read as Code 02 Electrical Engineering Works and Maintenance and Code 08 Mechanical Engineering Works and Maintenance respectively.
  - 1.3. Accounting Officers are accordingly informed to take into account the above developments when planning and preparing their respective tender documents and to ensure the cessation of using Code 04 Works Maintenance as it does no longer exist. All are advised to now commence using either Code 02 Electrical Engineering Works and Maintenance or Code 08 Mechanical Engineering Works and Maintenance as necessary for Electrical and Mechanical maintenance works.
- 2. Procuring Entities are urged to observe these developments and use the relevant code after verifying the existence of such code, sub code and or grade in the public domain of the IPMS. This verification will ensure correct use of codes, sub codes and grades thereby averting delays in the tendering process that may be occasioned as a result of the use of wrong codes, leading to cancellation of tenders.
