

PUBLIC PROCUREMENT REGULATORY AUTHORITY BOARD

The Public Procurement Regulatory Authority (the Authority) is pleased to announce the appointment of the Public Procurement Regulatory Authority Board (the Board), appointed by the Minister of Finance in terms of section 13 (1) of the Public Procurement Act of 2021 (the Act). The Board's appointment is with effect from 14th April 2022.

The Authority's mandate in terms of the Act includes setting standards and practices for the public procurement system, regulating and controlling the public procurement system. The Authority is also responsible for monitoring of performance of procuring entities and enforcement of compliance with the Act. The mandate of the Authority also includes providing and supporting capacity building and professionalization of public procurement cadre.

Mr. Gerald Nyadze Thipe is a seasoned economist holding a Bachelor of Arts (Economics) from the University of Botswana and Swaziland as well as a Postgraduate Diploma in Development Economics from the University of East Anglia, Norwich, United Kingdom in 1981.

He began his career in the Public Service in June 1978 and was deployed to the then Ministry of Finance and Development Planning as an Assistant Planning Officer. He rose through the ranks until he was appointed Permanent Secretary for the then Ministry of Works and Transport. He held this role from September 2002 to March 2008, following which, he was assigned to establish the Transport HUB office, spearheading the initiative to develop Botswana as a centre of excellence in transport and logistics in the SADC region.

He is an economist with wide ranging experience in project planning, appraisal and management; procurement; leadership and governance; and has held various directorships at both parastatal and private sector level. Serving on these boards has exposed him to issues of good corporate governance and acquainted him with procedures and processes of diverse range of organisations. Mr. Thipe was appointed to serve on the Public Procurement and Regulatory Authority Board from 14 April 2022 when the PPADB was transformed and re-established as the Public Procurement Regulatory Authority.
